## ABOUT THE STUDENT

If a Grand Prize Winner does not agree to perform an alternative music selection, the prize(s) to be awarded to such Grand Prize Winner will be forfeited and, at Sponsor and Houston Symphony's discretion, an alternate Grand Prize Winner may be selected by the judges.
